- 6 That the results shall be satisfactory every year and not to be announce the ranks in SSC Public Examinations as per the G.O Ms.No.49 Edn. (PS), dt.26.02.98.
- 7 That the records/accounts shall be furnished to the D.E.O every year by 31st March, at the latest
